## **8 Notices of Motion**

- Amendment to the Constitution by Special Resolution – to Sections 13, 19 and 32 – **the Treasurer to be an appointed Board position with full voting rights**  
Discussion held. The Treasurer has a significant input into the business. Will result in 9 voting Board Members. Noted that the appointment process for the Treasurer requires clarification – Fencing NZ to develop and formally adopt a policy for appointments, which will involve appointment of a panel to recommend a candidate to the Board. Noted that Sport NZ require Boards to be 40% female to qualify for funding.

- Amendment to the Constitution by Special Resolution – to Section 4.5 - amend the **Junior Membership Category to persons under 16 years' old**  
Discussion held. Stephen presented analysis of the impact of 16 year olds voting. Impact not significant. 16 year olds can hold office but should not sign contracts.

- Amendment to the Constitution by Special Resolution – Sections 19 and 41 - to **clarify the process for election ballots**
